### 7 Review of Member Role Descriptions

This report asked Members to review the Role Descriptions for the Chair and Vice-Chair of the Strategy and Resources Committee and the Chair of the Strategic Risk and Planning Working Group.

Councillor Carter asked whether the proposed deletion of reference to Integrated Risk Management Planning and replacement with Strategic Risk and Planning processes would have any implications with Communities and Local Government. The Chief Fire Officer replied that it would not.

The Committee noted that, although the Working Group would no longer be involved in consultations with staff, it still had a very important role to play in the strategic planning process. Councillor Mrs Barrow felt that Members should still be able to visit stations, if they wished. Councillor Carter added that during the Public Value process the Group had undertaken to provide feedback to staff about changes in shift systems. The Chief Fire Officer responded that Members were welcome to participate in the meetings, which he and the Deputy and Assistant Chief Fire Officers attended at each station.
