1 Purpose of Report

This report reviews progress against the Strategy and Resources Committee 2015/16 Work Plan and puts forward a 2016/17 Work Plan for consideration and approval by Members.

2 Recommendations

3 Background

Since March 2009 the business of the Strategy and Resources Committee has been conducted in accordance with an annual Work Plan. The Plan sets out in a structured manner what the Committee's activities will be throughout the year, thus ensuring that the responsibilities imposed by its terms of reference will be carried out in a timely manner and that no deadlines will be missed.

The draft 2016/17 Work Plan is attached as an appendix to this report for consideration by the Committee.

4 Review of 2015/16 Work Plan

Having carried out a review of the 2015/16 Work Plan, officers can confirm that all of the activities, listed in the Plan, have been carried out or are on the agenda for this meeting, with the exception of those listed on the following page.



Item 2 report on financial performance July 2015

In the first part of the financial year officers are occupied with preparing the Statement of Accounts and do not provide their first monitoring report until June. In light of this there is very little financial information for the Committee to receive in July.

Item 7 Report on Integrated Risk Management / 2020 Planning September 2015

Rather than report to the September meeting of the Committee and then on to the full Fire Authority, officers provided a comprehensive presentation to the Fire Authority at its meeting on 7 October 2015 on the following projects:

- Staffing Model Review
- Fire Control Review
- Review of Telford Central site requirements

Item 10 report on capital activity and finance November 2015

The Committee received a report on capital activity and finance in September 2015. As only two months had elapsed, when the November meeting of the Committee took place, there was little, additional information to present to the Committee.

Item 11 report on corporate risk management November 2015

The Committee received a report in September 2015 on corporate risk management, so similarly to the above, there was little, additional information to present to the Committee at the November meeting.

In future it is proposed that, rather than present separate reports on corporate risk, officers will include consideration of corporate risk in the reports on financial performance and on provisions and reserves. This will enable the Committee to focus on any risks, which have the potential to affect its decision making.

Item 22 report on capital activity and finance March 2016

The Committee received a report in February 2016, so similarly to the above, there is little, additional information to present to the Committee at this March meeting.

In light of this officers propose that, in the Work Plan for the forthcoming year, reports on capital activity and finance are presented to the Committee in September and February.

5 Proposed 2016/17 Work Plan

During the review officers also considered what activities should be included in the next Work Plan, taking into account any recent developments. Attached as an appendix to this report is a draft 2016/17 Work Plan, outlining all of the actions which, it is expected, the Committee will need to carry out during the coming year.



The Committee is asked to provide any comments or suggestions with regard to the attached draft Work Plan and approve the contents.

6 Financial Implications

There are no direct financial implications attached to the approval of the Work Plan itself. There may, however, be financial implications associated with a number of the actions listed, for which individual reports will be brought to the Committee as necessary, detailing those specific implications.

7 Legal Comment

The Strategy and Resources Committee is not legally required to have in place a Work Plan. This does, however, represent good practice. The decision to approve the Work Plan will not affect the discretion of the Committee during the forthcoming year, as it can, at subsequent meetings, decide to amend the Work Plan, if it is necessary to do so.

8 Initial Impact Assessment

This report provides only historical information and sets out a series of actions to be completed over the coming year. An Initial Impact Assessment has not, therefore, been completed. It is possible, however, that such assessments may be required in respect of individual actions contained within the Work Plan, in which case they will be completed at the appropriate time.
