1 Purpose of Report

This report presents proposed increases in charges made for special services.

2 Recommendations

The Fire Authority is asked to consider and decide upon the proposed charges for special services to be applied from 1 April 2017.

3 Background

Charging for special services is currently permitted by Orders issued under Section 18 parts a, b and c of the Fire and Rescue Services Act 2004. This report lays out proposed increases to the current tariff of charges.

The charges for special services are reviewed annually.

4 Annual Review

It is proposed that the remaining charges on the tariff are increased by 1%, the pay increase which was awarded to firefighters in 2016/17.
