1 Purpose of Report

This report updates the Committee on issues relating to the ethical framework and brings the following procedures and documents to the notice of its Members:

3 Background

This Committee is now an amalgamation of the Fire Authority's former Standards and Human Resources Committees. As this is the first meeting of the new Committee and not all of its membership has been involved in ethical framework issues, it is appropriate to provide an update on these issues and to bring certain procedures and documents to the notice of Members.

4 Update on Ethical Framework Issues

Complaints

There have been no complaints in 2013/14 relating to breaches of the Fire Authority's Code of Conduct.

Independent Person

The Fire Authority's Independent Person is Chris Humphries, who acts also as Independent Person for Telford & Wrekin Council. He has access to training, guidance and support from Hoey Ainscough, a company established by former employees of Standards for England. There is no cost to the Fire Authority, as this is met by Telford & Wrekin Council. Such support is particularly important, given that Members, who are subject to a complaint, have the option of contacting the Independent Person directly during the complaints process.

5 Procedures and Documents

Members' notice is drawn to the following procedures and documents, which form the basis of the standards element of the Committee's work. All were reviewed by the Standards Committee in September 2013 and any amendments recommended were approved, where necessary, by the Fire Authority later that month. The next review of these documents is scheduled in the Committee's Work Plan for October 2014.

Links to these documents have been provided, rather than appending them to this report, in order to save on paper and postage.

The Fire Authority's Code of Conduct complies with the provisions of section 28 of the Localism Act 2011, namely it enshrines the following principles:

- Leadership
