# Preparation of Annual Service Plan and Statement of Assurance

#### 1 Purpose of Report

This report informs Members of proposed arrangements to develop and publish the Fire Authority's annual Service Plan and the newly required Statement of Assurance in a format that satisfies Government expectations.

#### 2 Recommendations

The Fire Authority is asked to:

- a) Note the contents of this report, particularly in respect of the requirements of the Fire and Rescue Service National Framework;
- b) Approve proposals for the preparation of a:
  - i 'Forward looking' Service Plan 2013/14; and
  - ii 'Backward looking' Annual Report 2012/13 (subtitled as the Annual Statement of Assurance); and
- c) Delegate responsibility to the relevant committees, working with officers, to oversee preparation of the above documents prior to final approval by the Fire Authority.

## 3 Background

In recent years the Fire Authority, largely through the Public Value process, has sought to simplify and streamline the content and publication of the annual Service Plan.

The Service Plan<sup>1</sup> acts as a 'forward looking' document, setting out the Authority's purpose, priorities, aims and performance measures for Shropshire Fire and Rescue Service. The Plan is supplemented by a 'backward looking' Annual Report<sup>2</sup> that summarises the Authority's performance against the contents of the previous year's Plan.

During 2012 the Government published a new Fire and Rescue Service National Framework<sup>3</sup>, a Framework that has implications for the Authority's previous approach to the development and publication of both the Service Plan and Annual Report.

#### 4 Fire and Rescue Service National Framework

National Frameworks for Fire and Rescue Authorities (FRAs) have been in existence since 2004 and cover a broad range of activities and responsibilities, including resilience, prevention, protection and response. The emphasis is to promote local accountability, while focusing on issues where there is a clear national interest, for example national resilience.

The current Framework sets out the high-level expectations, priorities and objectives for all FRAs over the next few years, and how the Government will work in partnership with them and other stakeholders. The Framework does not prescribe operational matters but expects FRAs to assess all foreseeable fire and rescue related risks that could affect their communities, and put in place arrangements to mitigate these risks. This may be through adjusting existing provision, more effective collaboration and partnership working, or building new capability. It adds that FRAs need to be prepared for incidents of such scale or complexity that local resources may be overwhelmed, even when taking into account mutual-aid agreements.

The Fire Authority's '2020 Strategy' (to be considered at agenda item 15) addresses preparations to review and adjust the existing Integrated Risk Management Plan to take account of these additional requirements.

Despite the Government handing over greater control to FRAs, the Framework indicates that the Government will retain strategic responsibility for national resilience and will continue to fund existing national resilience capabilities.

The Framework, however, makes it clear that the leadership role of FRAs is critical in handling any national-level emergency, and that national resilience must be drawn from the local capability, expertise and knowledge within fire and rescue services.

With FRAs ultimately accountable to their local communities, the Framework also states that all FRAs need to be transparent about decisions and actions taken, and engage with communities so that local people can scrutinise and influence service delivery. They should also ensure that local communities can access information to compare the performance of their FRA with others. To this end, the Government has stated that robust mechanisms should be in place to provide independent assurance to communities and to the Government. The Framework details (paragraph 3.2) important measures, which will ensure that FRAs provide assurance and local scrutiny arrangements.

#### **5** Providing Community Assurance

Mindful of the Fire Authority's statutory obligations in respect of meeting the Framework's requirements, officers propose the restructure of both the existing Service Plan and Annual Report to reflect the Government's expectations. The forward looking Service Plan will be presented in such a manner that it addresses each of the Framework's 18 mandatory 'must do' requirements. The Service Plan will also be directly aligned to the Government's requirements<sup>4</sup> for the backward looking Annual Statement of Assurance (to be known locally as the "Annual Report"). The intention is to publish two broadly similar looking documents that, in future years, will provide direct read-across, with one setting out what the Fire Authority intends to do, and the other recording what the Authority has actually achieved.

Whilst the structure of these two documents will address Government requirements, it is proposed that the style and content is deliberately aimed at a readership within the local community and presented in plain English (as opposed to being written in a style and language exclusively for auditors, as has had happened in the past with Best Value publications). The aspiration is that both documents would be to a standard equivalent to the 'Crystal Mark' awarded by the Plain English Campaign.<sup>5</sup>

The outcome of these proposals would provide a set of linked documents that aim to raise awareness and provide assurance within the community of the role, challenges, priorities and performance of the Fire Authority and its provided fire and rescue service.

#### 6 Structure and Content

The appended Table 1 sets out the proposed table of contents for both the Service Plan and Annual Report (columns 1 and 3). Also included within Table 1 are the results of a cross-referencing / mapping exercise to the National Framework (column 2) and guidance regarding Statements of Assurance (column 4). The cross-referencing exercise shows the relationship of the table of contents of each document to the Government's expectations.

A description of the indicative contents within each document section is provided within column 5.

It should be stressed that both documents will act as summary documents, with references / hyperlinks provided to signpost the reader to more detailed sources of reference (e.g. Service and Government websites / pages etc.).

Both documents would be readily available via the Service's website, with the intention that neither would be published in hard-copy format (unless specifically requested). In addition, a summary (A3 size) single page Service Plan will be published and circulated to stations / departments as in previous years.<sup>6</sup>

#### 7 Next Steps

Subject to Member approval and delegation to the respective committees, the next steps will be to:

- a) Prepare the draft contents of the Service Plan 2013/14 for consideration by the Fire Authority's Strategy and Resources Committee on 14 March 2013:
- b) Present the final draft of the Service Plan 2013/14 for approval by the Fire Authority on 24 April 2013;
- c) Prepare the draft contents of the Annual Report 2012/13 (Annual Statement of Assurance) for consideration by the Fire Authority's Audit and Performance Committee on 5 September 2013; and
- d) Present the final draft of the Annual Report 2012/13 (Annual Statement of Assurance) for approval by the Fire Authority on 25 September 2013. This proposal is on the understanding that the Annual Statement of Accounts 2012/13 has been approved at or around this time.

### 8 Financial Implications

There are no additional financial implications to the Fire Authority associated with the preparation and publication of the proposed documents. The development of these documents to satisfy Government requirements will, however, place an additional administrative burden upon officers.

## 9 Legal Comment

Section 21 of the Fire and Rescue Services Act 2004 provides the statutory authority for the Fire Service National Framework and requires FRAs to have regard to the Framework in carrying out their functions.

Members should have due regard to the new Framework and, in particular, paragraph 3.2 in the Framework (as discussed above).
