Welcome to the latest edition of the Ethical Standards Bulletin. This Bulletin is distributed to elected members from Telford & Wrekin Council, Parish and Town Councils in the Borough of Telford & Wrekin and members of the Shropshire and Wrekin Fire and Rescue Authority.

Support for Code of Conduct

There's a high - and growing - level of support among councillors for the national Code of Conduct covering their behaviour.

Councillors and council officers recognise the importance of high standards to local democracy, and they are increasingly supportive of the work of the Standards Board for England, the national regulator of councillor behaviour.

The Standards Board for England researches the views of councillors and council officers every two years.

This year's survey shows support for the Code of Conduct and the local standards framework is at an all time high:

- More than 70% feel that it is right for complaints to be handled locally
- 89% are confident that their authority is doing a good job of upholding standards
- Four times as many agree as disagree that 'member's standards of behaviour have improved over recent times.'

"The Standards Board will continue to support authorities in this essential work, providing the expert, independent national scrutiny needed to protect standards and boost public confidence in local democracy."		
New Regulations Issued			
The Government has issued new Regulations in respect of the ethical framework in local government. The Standards Committee (Further Provisions) (England) Regulations 2009 (SI:1255) set out three main provisions:-	Secondly, a change in the rules in respect of the granting of dispensations by Standards Committees. We have updated the dispensation application form and produced some guidance which will be circulated shortly.		
Firstly, the power for the Standards Board for England to intervene if they consider that a Standards Committee is not undertaking its duties effectively, including the power to suspend the assessment functions of a standards committee. Three-year ban for Dartmouth councillor A Dartmouth Town councillor was disqualified for three years following a Standards Board for England investigation.	Councillor Boughton, who is also a former member of South Hams District Council, was alleged to have bullied and undermined the Dartmouth town clerk over a long period. He subjected the clerk at one stage to almost

The Adjudication Panel for England, an independent judicial tribunal, agreed with the Standards Board's ethical standards officer that Councillor Brian Boughton had breached the Code of Conduct by bullying a council	daily visits in the council's offices, during which he would frequently become aggressive, angry and intimidating in front of officers and members. He also repeatedly accused the clerk of incompetence, to his face and to others.
Councillor Boughton's conduct at council meetings, attended by the local press and the general public, was often aggressive, and was so disruptive that on one occasion, a senior police officer attending the meeting believed it to be verging on public disorder and considered intervening.	Dr Robert Chilton, chair of the Standards Board, said: "Councillor Boughton's conduct was not only personally distressing to a number of individuals, but also brought his office and authority into disrepute and affected the smooth running of the council.
He was also disrespectful to other members, referring to the mayor as a 'bloody hypocritical bitch', and claiming in a letter to a new member that two of their fellow councillors were showing 'signs of serious dementia'. Council staff found his discussions with other members so heated that they had to ask for the conversations to be held elsewhere, as they disturbed the running of the council office.	"People have every right to expect high standards from those elected to represent them, and in falling so far short of those standards, Councillor Boughton has seriously undermined the public's trust and confidence in local democracy. The three-year disqualification recognises this, and sends a clear message to the electorate that councillors who breach the Code of Conduct can be brought to account."

Code of Conduct Training

Improvements have been made to the format of each session which will now include workshops using real case scenarios.
