1 Purpose of Report

This report submits the 2006/07 Annual Efficiency Statement (AES) for scrutiny by the Fire Authority. The return itself was required to be submitted by 5 July 2007, but any amendments can be notified to Communities and Local Government (CLG).

2 Recommendations

The Fire Authority is recommended to approve the 2006/07 Backward Looking Annual Efficiency Statement

3 Background

The Authority has a policy of seeking to provide best value and therefore to maximise efficiencies. The Authority has set a policy of trying to match its disaggregated share of the national fire service target for efficiencies. This would mean finding £930,000 between 2004/05 and the end of 2007/08. The Authority is aware however that this might be difficult for itself (and other authorities) who had made efficiencies before the period for the national target.

4 2006/07 Efficiencies

The appendix summarises the position, which has been well reported to previous meetings. The main differences between the figures now reported for 2006/07 are

i Procurement: Additional one-off savings of £18,000 have been identified from using Firebuy contracts for appliances, equipment and radios. This has offset a reduction of £10,000 in general savings on purchasing.



ii Efficiencies through effective use of the vehicle workshop total £9,000, compared to an estimate of £14,000.

5 Summary

The Fire Authority remains above the nationally disaggregated milestone efficiencies anticipated to have been achieved by the end of 2006/07.
