# 1 Purpose of Report

To propose to Members of the Committee a structure for the latest development of the Fire Authority's Medium Term Financial Plan (MTFP).

# 2 Recommendations

The Committee is asked to:

- a) Agree the proposed structure for the 2009/10 update of the Fire Authority's MTFP; and
- b) Agree to the inclusion within the MTFP of the outcomes of an analysis of the Audit Commission's recently published national report into 'improving fire service efficiency.'

# 3 Background

In 2006 the Fire Authority published its first MTFP, which covered a three-year period and confirmed the Fire Authority's continued commitment to providing a Fire and Rescue Service, which represents the best possible value for money for Shropshire's residents. The MTFP was thus established and embedded as an important part of the strategic planning process. It ensures that financial planning of the Authority links closely to its Service planning and thus to the delivery of the Fire Authority's five strategic aims.



In 2007 the MTFP (in conjunction with the associated Performance Plan) was updated to take account of local, regional and national developments. The Plan described what appeared to be a continuing and favourable (if gradual) shift of central government controlled resources towards more rural fire and rescue services, such as Shropshire. The Plan also, however, highlighted that the major problem facing the Fire Authority at that time was due to widespread uncertainty over future funding, brought about by Government's planned Comprehensive Spending Review due to be completed during 2007 (CSR07).

The results of CSR07 were made known during December 2007 when Government provided the Fire Authority with information on its grant settlement for the next three years. This was the first occasion on which such information had been made available for a period of longer than one year, and was extremely useful in enabling the Fire Authority to enhance even further its MTFP for 2008/09 to 2011/12.

#### 4 MTFP 2009/10 to 2011/12

The Fire Authority's financial planning process is now well established. It is recommended that this year's update of the MTFP does not, therefore, involve major changes to the structure and layout of previous plans. As such, it is proposed that the Plan will once again consist of the following sections:

# 5 Audit Commission National Research

At a meeting of the Fire Authority on 11 February 2009, Members were brought up-to-date with the findings of a national research project undertaken by the Audit Commission, which had culminated in their identification that *"the service overall could save up to £200 million"* and also in their publication of a document entitled 'Rising to the challenge: improving fire service efficiency.' Members noted the major findings of the report and tasked officers with carrying out an in-depth analysis of these findings as they apply to Shropshire and Wrekin Fire and Rescue Authority and reporting back to the April 2009 meeting of the Fire Authority.

It is anticipated that the findings from this further analysis will be very beneficial in assisting the Fire Authority with its ongoing drive to force out efficiencies and thus provide improved value for money for the taxpayers of Shropshire. It is, therefore, recommended that the findings of the analysis, when approved by Members, should be included within the 2009/10 update of the MTFP, which will then be prepared for publication during June/July 2009 in the normal manner.
