1 Purpose of Report

This report proposes amendments to the terms of reference of the Strategy and Resources Committee, following a review by officers, for recommendation to the Fire Authority.

2 Recommendations

Members are asked to recommend to the Fire Authority the proposed amendments to the terms of reference of the Strategy and Resources Committee, attached as an appendix to this report, subject to any amendments / comments they may wish to make.

3 Background

Although the terms of reference of all committees are reviewed each year at the Annual Meeting of the Fire Authority, no fundamental review of those of the Strategy and Resources Committee has taken place since it was first established in October 2005. Officers recently conducted such a review for the Audit and Performance Management Committee and felt it timely, therefore, to carry out one for this Committee to ensure that its terms of reference are clear and include all responsibilities, which the Committee should discharge.

An action to review the terms of reference is included in the Committee's 2009/10 work plan for completion in May 2009, which will enable the Fire Authority to consider any amendments, recommended by the Committee, at its Annual Meeting on 3 July 2009.



4 Proposed Terms of Reference

The draft terms of reference of the Committee are attached as an appendix to this report, with proposed deletions struck through and additions shown in bold, italic type. They now include more specific responsibilities, which mirror, to a large extent, the actions set out in the Committee's work plan.

5 Financial Implications

There are no direct financial implications attached to the proposed constitution. There may, however, be financial implications associated with some of the responsibilities listed, for which individual reports will be brought to the Committee as necessary, detailing those specific implications.

6 Legal Comment

The draft terms of reference appended to this report include mention of some of the legal responsibilities placed upon the Fire Authority, for example the obligations relating to the Statement of Accounts, which are set out in the Accounts and Audit Regulations 2003 (as amended). Accordingly, the work of the Committee (as set out in the terms of reference) assists the Fire Authority in complying with its legal obligations.

Any proposed changes to the Committee's terms of reference will have to be approved at a meeting of the full Fire Authority.

7 Equality Impact Assessment

Officers have considered the Service's Brigade Order on Equality Impact Assessments (Personnel 5 Part 2) and have decided that there are no discriminatory practices or differential impacts upon specific groups arising specifically from this report. An Initial Equality Impact Assessment has not, therefore, been completed.

To receive and consider any exemptions under the Authority's Standing Orders relating to Contracts and advise as appropriate

To consider value for money issues

To oversee, review, and make recommendations to the Authority on, the management of all financial and physical resources



To review the Treasury Policy Statement and monitor the performance of the treasury management function in accordance with policy

To ensure that the financial management of the Fire Authority is adequate and effective and includes a sound system of internal control and arrangements for the management of risk

To receive the Statement of Accounts and, following approval, to ensure that it is signed in accordance with the Accounts and Audit Regulations 2003 all relevant legislative requirements

To give final consideration to annual efficiency statements prior to submission to Government

To consider the structure of the Medium Term Financial Plan, provide feedback on the draft Plan and make recommendations to the Authority

To monitor budgeting and financial performance, consider any actions proposed by officers and make recommendations to the Authority, where appropriate, including reporting any virements to the Authority for approval
