Contracts Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest ⁴) and the Authority — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

⁴ "body in which the relevant person has a beneficial interest" means a firm, in which you or your partner is a partner or a body corporate, of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society

⁶ “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society

- c) A matter that **directly relates** to your financial interest or well-being (and is not a Disclosable Pecuniary Interest set out in Table 1) or a financial interest or well-being of a relative or close associate
- d) A matter that affects: -
 - a. Your own financial interest or well-being
 - b. A financial interest or well-being of a relative, close associate; or
 - c. A body included in those you need to disclose under non-pecuniary interests, as set out in this paragraph.

Notes on sensitive interests
